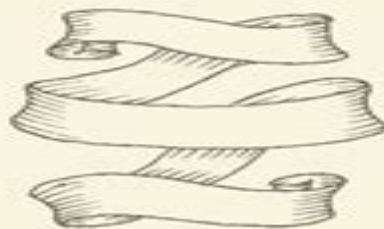

implemented in the 1930s with the goal of minimizing burdens for beneficiaries As a result the take up rate is about 100 percent because the Social Security Administration keeps track of peoples earnings for them automatically calculates benefits and eligibility and simply requires an easy online enrollment or visiting one of 1 200 field offices Making more programs and public services operate this efficiently the authors argue requires adoption of a nonpartisan evidence based metric for determining when and how to institute administrative burdens with a bias toward reducing them By ensuring that the public s interaction with government is no more onerous than it need be policymakers and administrators can reduce inequality boost civic engagement and build an efficient state that works for all citizens
