- The reform of electricity markets encompasses a wide range of measures.
- In general electricity industry restructuring implied:
 - ✓ *a separate transmission company;*
 - ✓ *partially or totally privately owned generation companies;*
 - ✓ *competition in generation;*
 - ✓ *retail supply opened to competition;*
 - ✓ *privately owned transmission and distribution network with third party access based on published and non-discriminatory terms and conditions.*
- Electricity industry restructuring has been accompanied also by the reform of the institutional design resulting in a set of institutional bodies:
 - ✓ *ministry handling most regulatory responsibilities directly;*
 - ✓ *independent regulatory agencies separate from ministry taking care of some particular responsibilities operating on the base of public consultation and other procedures meant to enhance transparency;*
 - ✓ *presence of ministerial regulatory agencies subordinated to the ministry but operating autonomously in the management of regulatory affairs.*
