02 | SECOND TRIMESTER

- **14–22 weeks:** alpha-fetoprotein (AFP) test
- **15–20 weeks** (*and up to birth*): amniocentesis
- **15–22 weeks:** multiple marker test
- **18–20 weeks:** mid-trimester ultrasound
- **After 18 weeks:** cordocentesis

01 | FIRST TRIMESTER

- **6–8 weeks:** early ultrasound
- **After 9 weeks:** cell-free fetal DNA testing
- **10–13 weeks:** chorionic villus sampling (CVS)
- **11–13 weeks:** first trimester screening, including maternal serum/blood tests and ultrasound

03 | THIRD TRIMESTER

- **28–40 weeks:** ultrasound
