Where one's freedom and livelihood are at stake, society should be very careful to protect a person's presumption of innocence. Whilst it is included in the Universal Declaration of Human Rights it is not an enforceable legal right. It can land often all excluded or modified at any time by an Act of Parliament.

This protects the accused and ensures they are:

- · informed of the charge and any relevant evidence

- protected from coercion (or torture) where their testimony might incriminate them (right to silence)
- not disadvantaged where the occuser has greater financial resources and power, and
- tried for a specific crime that is against the law and not for their race;
   religion, association or crime of another person

This also provides checks and balances on the accuser to stop them from misusing their power.
