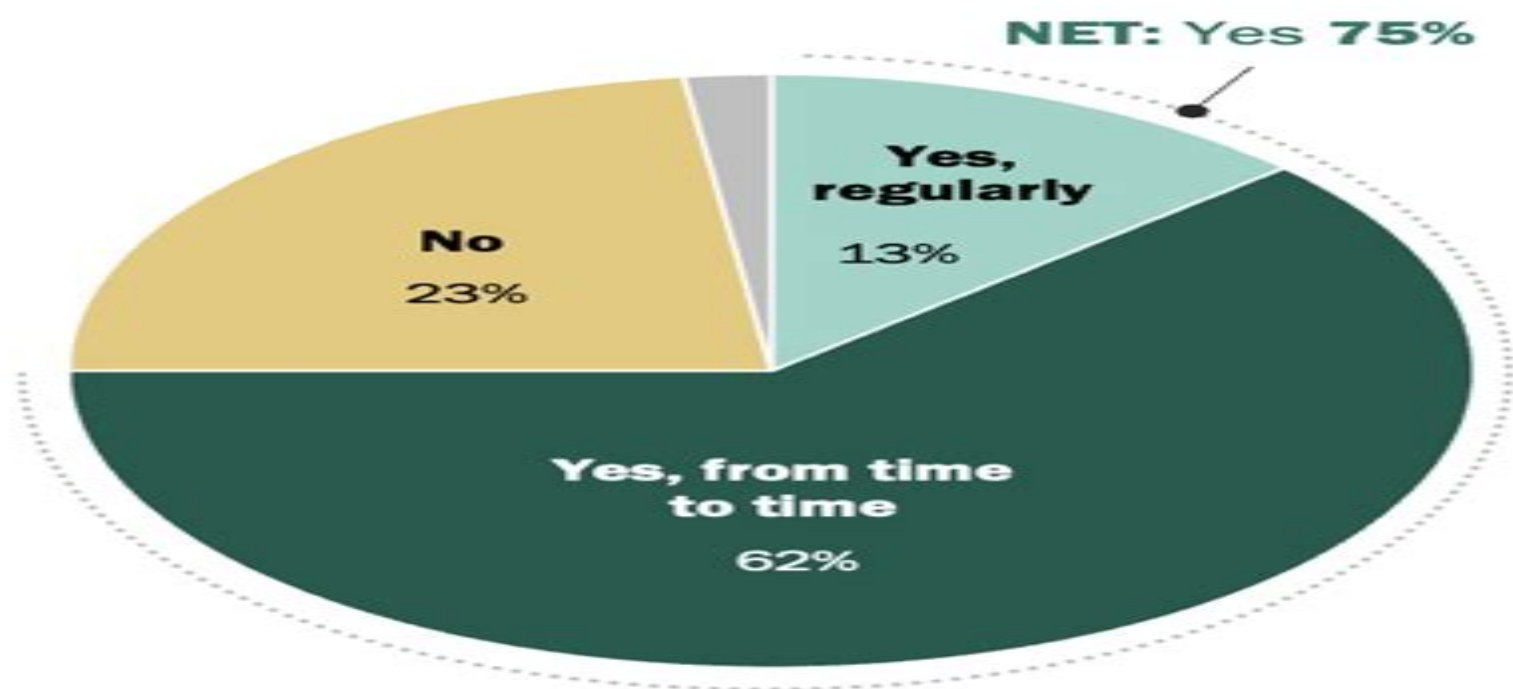


# The majority of Black adults say they have experienced racial discrimination
