No, because the conveyance violates one of the four unities—the unity of interest.

The unity of interest requires that the joint tenants hold estates that will last the same amount of time. Here, they don't; Howell gets only a life interest, while Skipper's interest is not limited. Since the conveyance violates the unity of interest, the joint tenancy fails, and instead a tenancy in common is created.
