Johnson-Dylewski, 2003-10-31 In this thoughtful sophisticated book John B Boles and Bethany L Johnson piece together the intricate story of historian C Vann Woodward s 1951 masterpiece *Origins of the New South* 1877 1913 published as Volume IX of LSU Press s venerable series *A History of the South* Sixteen reviews and articles by prominent southern historians of the past fifty years here offer close consideration of the creation reception and enduring influence of that classic work of history It is rare for an academic book to dominate its field half a century later as Woodward s *Origins* does southern history Although its explanations are not accepted by all the volume remains the starting point for every work examining the South in the era between Reconstruction and World War I In writing *Origins* Woodward deliberately set out to subvert much of the historical orthodoxy he had been taught during the 1930s and he expected to be lambasted But the revisionist movement was already afoot among white southern historians by 1951 and the book was hailed Woodward s work had an enormous interpretative impact on the historical academy and encapsulated the new trend of historiography of the American South an approach that guided both black and white scholars through the civil rights movement and beyond This easily accessible collection comprises four reviews of *Origins* from 1952 to 1978 *Origin of Origins* a chapter from Woodward s 1986 book *Thinking Back The Perils of Writing History* that explains and reconsiders the context in which *Origins* was written five articles from a fiftieth anniversary retrospective symposium on *Origins* and three commentaries presented at the symposium and here published for the first time A combination of trenchant commentary and recent reflections on Woodward s seminal study along with insight into Woodward as a teacher and scholar *Fifty Years Later* in effect traces the creation and development of the modern field of southern history *The American South* William James Cooper (Jr.), Thomas E. The New Woman in Alabama Mary Martha Thomas, 2020-10-06 Between 1890 and 1920 middle class white and black Alabama women created many clubs and organizations that took them out of the home and provided them with roles in the public sphere Beginning with the Alabama Woman's Christian Temperance Union in the 1880s and followed by the Alabama Federation of Women's Clubs and the Alabama Federation of Colored Women's Clubs in the 1890s women spearheaded the drive to eliminate child labor worked to improve the educational system upgraded the jails and prisons and created reform schools for both boys and girls Suffrage was also an item on the Progressive agenda After a brief surge of activity during the 1890s the suffrage drive lay dormant until 1912 when women created the Alabama Equal Suffrage

Association During their campaigns in the 1915 and 1919 to persuade the legislature to enfranchise women the leaders learned the art of politics how to educate organize lobby and count votes Women seeking validation for their roles as homemakers and mother demanded a hearing in the political arena for issues that affected them and their families In the process they began to erase the line between the public world of men and the private world of women These were the New Women who tackled the problems created by the industrialization and urbanization of the New South By 1920 Alabama women had created new public spaces for themselves in these voluntary associations As a consequence of their involvement in reform crusades the women s club movement and the campaign for woman suffrage women were no longer passive and dependent They were willing and able to be rightful participants Thomas s book is the first of its kind to focus on the reform activities of women during the Progressive Era and the first to consider the southern woman and all the organizations of middle class black and white women in the South and particularly in Alabama It is also the first to explore the drive of Alabama women to obtain the vote The development of political power among southern women progressed slowly Demolishing as it did the myth of the Southern Lady Traditionally confined to the domestic sphere southern women had no experience in public decision making and were discouraged from attaining the skills necessary for participation in public debate The division of women by race and class further impeded their political education But through their participation in so called women s issues child labor laws temperance and educational reform women gained experience in influencing political leaders Black and white women s clubs provided the framework for state wide lobbying Only in the wake of their success with domestic issues tackled through club organizations and temperance unions did women dare seek the right to vote They learned how to wield political power through acceptable ladylike avenues and it was this experience that led to their long but eventually successful drive for woman suffrage The New Woman eventually found a way to replace the Southern Lady

Matthew Hild,2010-02-25 Historians have widely studied the late nineteenth century southern agrarian revolts led by such groups as the Farmers Alliance and the People s or Populist Party Much work has also been done on southern labor insurgencies of the same period as kindled by the Knights of Labor and others However says Matthew Hild historians have given only minimal consideration to the convergence of these movements Hild shows that the Populist or People s Party the most important third party of the 1890s established itself most solidly in Texas Alabama and under the guise of the earlier Union Labor Party Arkansas where farmer labor political coalitions from the 1870s to mid 1880s had laid the groundwork for populism s expansion Third party movements fared progressively worse in Georgia and North Carolina where little such coalition building had occurred and in places like Tennessee and South Carolina where almost no history of farmer labor solidarity existed Hild warns against drawing any direct correlations between a strong Populist presence in a given place and a background of farmer laborer insurgency Yet such a background could only help Populists and was a necessary precondition for the initially farmer oriented Populist Party to attract significant labor support Other studies have found a lack of labor support to be a major reason for the failure of Populism but Hild demonstrates that the Populists failed despite significant labor support in many parts of the South Even strong farmer labor coalitions could not carry the Populists to power in a region in which racism and violent and fraudulent elections were tragically central features of politics

Race, Rape, and Lynching Sandra Gunning,1996-10-10 In the late nineteenth century the stereotype of the black male as sexual beast functioned for white supremacists as an externalized symbol of social chaos against which all whites would unite for the purpose of national renewal The emergence of this stereotype in American culture and literature during and after Reconstruction was related to the growth of white on black violence as white lynch mobs acted in defense of white womanhood the white family and white nationalism In Writing a Red Record Sandra Gunning investigates American literary encounters with the conditions processes and consequences of such violence through the representation of not just the black
