It defines a child as any human being under the age of 18 and calls on Parties to take all appropriate measures to ensure that children's rights are protected, including the right to a name and nationality, freedom of speech and thought, access to healthcare and education, and freedom from exploitation, torture and abuse. The CRC entered into force in Sept 1990 and has been ratified by 193 countries. Two countries, the U S and Somalia, have not ratified the CRC. This report provides an overview of the CRC's background and structure and examines evolving U S policy toward the Convention, including past and current administrative positions.
