Romania sought to lessen its economic and ideological dependence on the Soviet Union by expanding its trade ties and political relations with the Third World. In the case of East Germany, détente opened up new opportunities for relations with West Germany that were both lucrative in terms of trade and dangerous in terms of ideological pollution. Scholars of the Soviet bloc will find this book of interest.
