Secondly, while important recent work has explored the prevalence of child emperors in the late fourth and early fifth centuries, this book suggests a further evolution of the imperial role in the mid fifth century. Finally, while previous studies of this period have focused on Aspar's late career role in the succession struggles, a full study allows us to see how and why his relations with other key figures within and outside the eastern Roman government changed over the course of his lengthy career.
