Abstract

This Special Issue introduces the theoretical and methodological approach for specifying the character of the sociology of law through the concept of legal culture. Including this concept in the design of the sociological research can improve the questions towards legal phenomena and better identify the sociological perspective concerning other disciplines and legal knowledge. Still, it requires a better specification of what can be understood by legal culture from the sociological point of view. To this end, it proposes to refer to the concept, with "legal", to what is attributable to the legal institutionalisation of the normative dimensions of social life. "Culture", on the other hand, refers to cultural components to which recourse is made to reconnect those processes of institutionalisation to social norms, values and the more general cultural and social context of the law.
