Adverse Action

Through RouteOne, dealers can search for applications that may require Adverse Action notices, and automatically create an Adverse Action notice for those applicants. RouteOne will automatically populate the notice, generated as a portable document file (pdf) within the system, with the appropriate customer information, at which time the notice is ready for immediate printing and mailing by the dealer.

RouteOne also provides an "Adverse Action Manager", which allows dealers to filter and track applications that may qualify for an Adverse Action notice, and maintain a log of notices generated. Dealers may generate the notice whether or not they have requested a business pull from within RouteOne. The notice may be generated from the Deal Manager and Compliance Manager.
