Key Principles of the American Economy

The flow of resources, goods, and services is circular.

- Producers pay wages to individuals for the use of labor.
- Producers pay rent to individuals for the use of land.
- Producers pay interest to individuals for the use of capital.
- Producers produce goods and services for individuals.
- Individuals pay producers money for goods and services.

When there is free competition among sellers and among buyers, a market works according to laws of supply and demand.

- People tend to demand, or buy, more of a product when the price is low.
- More producers are willing to supply, or produce, a product and to supply more of it when the price is high.
- At higher prices, more of a product will be supplied but less will be demanded.
- At lower prices, less of a product will be supplied but more will be demanded.

The market price is the price at which buyers and sellers agree to trade.

- In an ideal market, quantity supplied and quantity demanded equal each other at this price.
- In the real market, prices may be higher or lower.
