citizens Religious law deemed to be the preserve of patrician priests was also excluded As Watson notes giving a monopoly of legal interpretation to the College of Pontiffs was a shrewd move to maintain patrician advantages however a fundamental consequence was that modes of legal reasoning appropriate for judgments in sacred law were carried over to private law where they were often less appropriate Such reasoning Watson contends persists even in modern legal systems After sketching the tenets of Roman religion and the content of the Twelve Tables Watson proceeds to such matters as formalism in religion and law religion and property and state religion versus alien religion In his concluding chapter he compares the law that emerged after the adoption of the Twelve Tables with the law that reportedly existed under the early Roman kings
