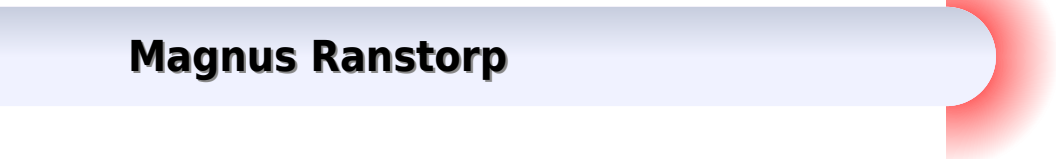
- Major legislative initiative since the IBA and Telecommunications Acts
- First draft of Bill published for comment in 2003 without a Green Paper and White Paper process
- Many complex policy issues underlying convergence have not been debated
- Essential to raise and debate issues to establish broad policy principles as basis for such fundamental legislation: market liberalisation, powers of ICASA, competition issues, transitional provisions
