- Rate of return regulation
 - typically used in US
 - rates usually set annually
- Incentive based regulation
 - performance based regulation / 'RPI X' regulation
 - rates / revenue set for a fixed number of years
 - incentive to make expenditure efficiency savings
- In both cases:

Total Revenue = Operating Costs + Depreciation + Return
