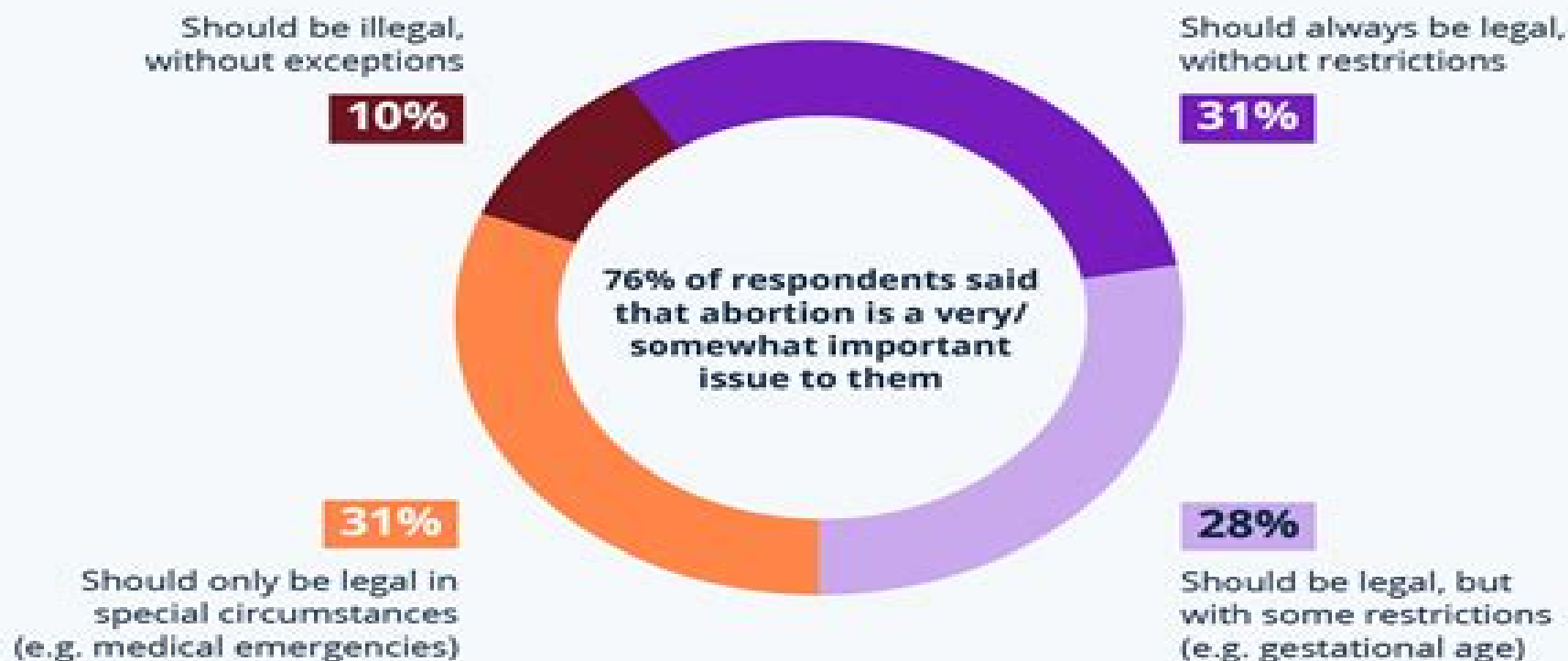


# Post-Roe v. Wade: Where Americans Stand on Abortion
