Long-term care includes non-medical care for people who have chronic illnesses or a disability. This includes personal care assistance - like help with everyday activities including dressing, bathing, meal preparation, and managing medications. At least 70% of people over 65 will need long-term care services at some point in their life. Medicare and health insurance plans, including Medicare Supplement Insurance (Medigap) policies, do NOT pay for this type of care. Long-term care can be provided at Home, in the Community, in an Assisted Living Facility, or in a Nursing Home. It is important to start planning for Long-term care now to be able to maintain your independence and to make sure you get the care you will need and in the setting you want. It's your life.. and it should be your choices.

How Do You Pay For Long Term Care?

LONG TERM CARE INSURANCE

This type of private insurance can help pay for many types of long-term care, including both skilled nursing and assisted living. Long-Term care insurance policies can vary widely. Some policies may cover only nursing home care. Others may include coverage for a range of services. Like adult day care, assisted living, medical equipment, and home health care. Long-term care insurance does not replace your Medicare coverage.

MEDICAID

Medicaid is a joint federal and state program that helps pay for certain health services for people with limited income and resources. If you qualify, you may be able to get help to pay for Nursing Home care, Assisted Living care, and other health care costs.

PERSONAL RESOURCES

You can use your own resources and money to pay for longterm care. Some life insurance companies may let you use your insurance policy to pay for long-term care. Besides longterm care insurance and personal resources, you may choose to pay for long term care through a Trust or an Annuity. The best option for you depends on your age, health status, risk of needing long-term care, and your personal financial situation.

VETERANS BENEFITS

The Department of Veterans Affairs (VA) has a Housebound and Aid & Attendance program that provides monthly income to eligible veterans who served during a wartime period as well as to their surviving spouses.
