STATE LIABILITY AND REMEDIES IN NATIONAL COURTS

Another way in which the ECJ has tried to mitigate the rejection of horizontal direct effect of directives is through the principle of State liability in damages for non-implementation of a directive. This third method of enforcement has become increasingly important and has been extended to cover breach of community law other than non-implementation of directives. Note that the question of damages against the State raised in this context is part of a much wider debate over the creation of remedies as part of the effective judicial protection obligation of national courts which we will explore later.

Article 340 TFEU
(ex Article 288 TEC)
The contractual liability of the Union shall be governed by the law applicable to the contract in question.
In the case of non-contractual liability, the Union shall, in accordance with the general principles common to the laws of the Member States, good any damage caused by its institutions or by its servants in the performance of their duties. [...]

But can you find in the TFEU—try as you might—a provision on state liability? - No. So, importantly, we are dealing here with a judicial creation.

1. STATE LIABILITY: DAMAGES AGAINST NATIONAL GOVERNMENTS

1.1 Failure to implement a Directive

Cases C-6&9/90 Francovich, Bonifaci & others v Italian Republic [1991] ECR I-5357

[33] It must be held that the full effectiveness of Community rules would be impaired and the protection of the rights which they grant would be weakened if individuals were unable to obtain compensation when their rights are infringed by a breach of Community law for which a Member State can be held responsible.

[35] It follows that the principle of State Liability for harm caused to individuals by breaches of community law for which the State can be held responsible is inherent in the system of the Treaty.

What do you think the reaction of Member States was to this judgment?

Does State Liability now fully mitigate for the tack of horizontal direct effect of directives?

The Court had previously indicated (as we will explore in session?) that the Treaty did not intend to create new remedies. Is this judgment consistent with this?
