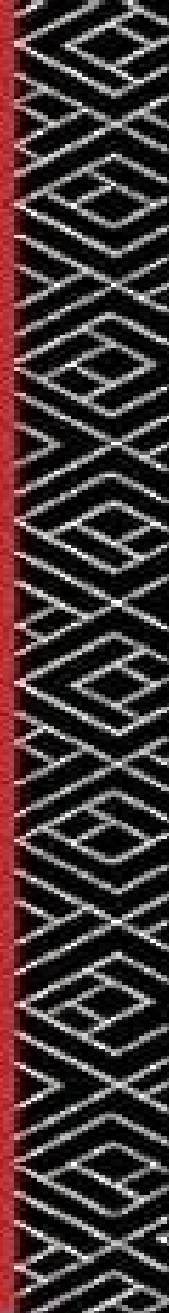
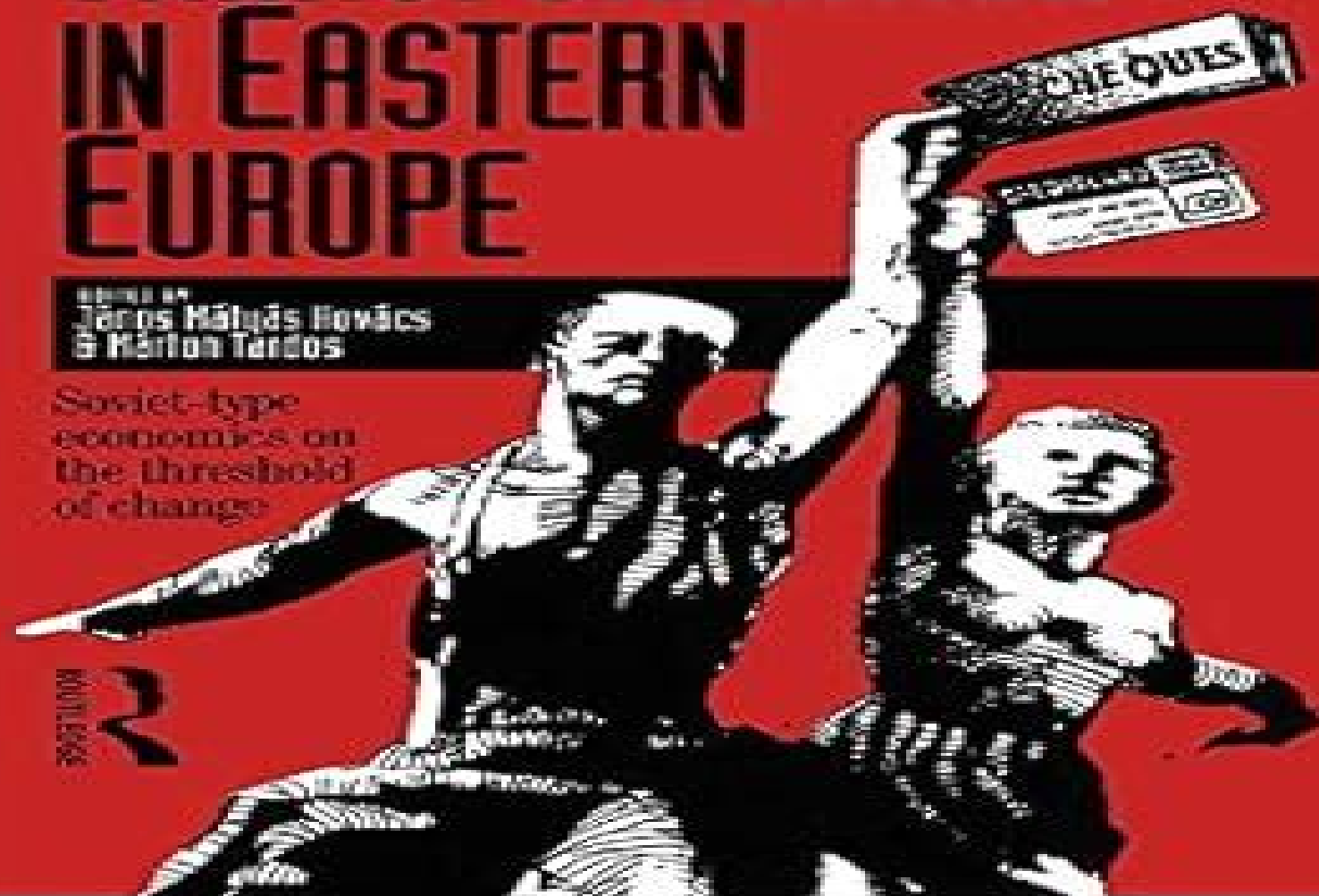

suffer from credit shortages and have limited access to information and advisory services. The barriers to market access prevent smallholders from fully exploiting their inherent productivity advantages. Best practice world experience highlights farmers service cooperatives created by grassroots users as the most effective way of improving the market access of small farmers. Service cooperatives also help smallholders overcome market failures when private business entrepreneurs are unwilling to provide services in areas that they judge unprofitable or unfairly exploit users through monopolistic practices.
