time under the intermediate projections The primary reason is demographics Between 2010 and 2030 the number of people aged 65 and older is projected to increase by 77% while the number of workers supporting the system is projected to increase by 7% In addition the trustees project that the system will run a cash flow deficit in each year of the 75 year projection period When current Social Security tax revenues are insufficient to pay benefits and administrative costs federal securities held by the trust funds are redeemed and Treasury makes up the difference with other receipts When there are no surplus governmental receipts policymakers have three options raise taxes or other income reduce other spending or borrow from the public or a combination of these options Public opinion polls show that less than 50% of respondents are confident that Social Security can meet its long term commitments There is also a public perception that Social Security may not be as good a value for future retirees These concerns and a belief that the nation must increase national savings have led to proposals to redesign the system At the same time others suggest that the system's financial outlook is not a crisis in need of immediate action Supporters of the current program structure point out that the trust funds are projected to have a positive balance until 2033 and that the program continues to have public support and could be affected adversely by the risk associated with some of the reform ideas They contend that only modest changes are needed to restore long range solvency to the Social Security system During the 111th Congress four Social Security reform measures were introduced None of the measures received congressional action In the 112th Congress several Social Security reform measures have been introduced none have received congressional action
