What is social justice?

Social justice is the promotion of human rights and the removal of inequality.

It acknowledges that external factors impact health.

The social justice principles include:

- Equity
- Diversity
- Supportive environments



EQUITY.

Equity is provision of resources to the disadvantaged to ensure equal and fair health for all population groups.

This results in priority population groups receiving additional funding as they have poorer health outcomes than other Australians.

Example:

The government initiative - 'Close the Gap' campaign provides funding and additional support to Indigenous Australians to ensure that their health outcomes are the same as non-Indigenous Australians. In particular, the campaign focuses on 'closing the gap' in life expectancy for the ATSI population.

DIVERSITY.

Diversity refers to the differences that exist between individuals and people groups.

It accepts cultural, religious and other differences to acknowledge the needs for all members of society.

Example:

Translation services are available to culturally diverse and linguistic people to ensure that they receive the same access to health services and facilities.

SUPPORTIVE ENVIRONMENTS.

Supportive environments are environments where people live, work and play that promote and support health.

Example:

Having 'no-smoking areas' in public places supports healthy choices to minimise smoking. It is a way to encourage individuals to quit smoking by creating a stigma of the risky behaviour not being socially acceptable.
