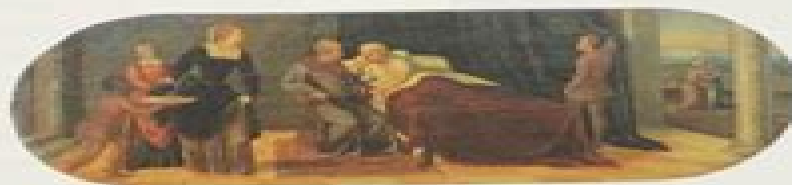

Private Lives in Renaissance Venice Patricia Fortini Brown, 2004-01-01 As the sixteenth century opened members of the patriciate were increasingly withdrawing from trade desiring to be seen as gentlemen in fact as well as gentlemen in name The author considers why this was so and explores such wide ranging themes as attitudes toward wealth and display the articulation of family identity the interplay between the public and the private and the emergence of characteristically Venetian decorative practices and styles of art and architecture Brown focuses new light on the visual culture of Venetian women how they lived within furnished and decorated their homes what spaces were allotted to them what their roles and domestic tasks were how they dressed how they raised their children and how they entertained Bringing together both high arts and low the book examines all aspects of Renaissance material culture **BOOK JACKET** *Venice's Intimate Empire* Erin Maglaque, 2018-06-15 Mining private writings and humanist texts Erin Maglaque explores the lives and careers of two Venetian noblemen Giovanni Bembo and Pietro Coppo who were appointed as colonial administrators and governors In *Venice's Intimate Empire* she uses these two men and their families to showcase the relationship between humanism empire and family in the Venetian Mediterranean Maglaque elaborates an intellectual history of Venice's Mediterranean empire by examining how Venetian humanist education related to the task of governing Taking that relationship as her cue Maglaque unearths an intimate view of the emotions and subjectivities of imperial governors In their writings it was the affective relationships between husbands and wives parents and children humanist teachers and their students that were the crucible for self definition and political decision making *Venice's Intimate Empire* thus illuminates the experience of imperial governance by drawing connections between humanist education and family affairs From marriage and reproduction to childhood and adolescence we see how intimate life was central to the Bembo and Coppo families experience of empire Maglaque skillfully argues that it was within the intimate family that Venetians relationships to empire its politics its shifting social structures its metropolitan and colonial cultures were determined *Coming of Age in Medieval Egypt* Eve Krakowski, 2019-03-19 Much of what we know about life in the medieval Islamic Middle East comes from texts written to impart religious ideals or to chronicle the movements of great men How did women participate in the societies these texts describe What about non Muslims whose own religious traditions descended partly from pre Islamic late antiquity *Coming of Age in Medieval Egypt* approaches these questions through Jewish women's adolescence in Fatimid and Ayyubid Egypt and Syria c 969 1250 Using hundreds of everyday papers preserved in the Cairo Geniza Eve Krakowski follows the lives of girls from different social classes rich and poor secluded and physically mobile as they prepared to marry and become social adults She argues that the families on whom these girls depended were more varied fragmented and fluid than has been thought Krakowski also suggests a new approach to religious identity in premodern Islamic societies and to the history of rabbinic Judaism Through the lens of women's coming of age she demonstrates that even Jews who faithfully observed

rabbinic law did not always understand the world in rabbinic terms By tracing the fault lines between rabbinic legal practice and its practitioners lives Krakowski explains how rabbinic Judaism adapted to the Islamic Middle Ages Coming of Age in Medieval Egypt offers a new way to understand how women took part in premodern Middle Eastern societies and how families and religious law worked in the medieval Islamic world

Domestic Institutional Interiors in Early Modern Europe Sandra Cavallo, 2017-07-05 The early modern period saw the proliferation of religious public and charitable institutions and the emergence of new educational structures By bringing together two areas of inquiry that have so far been seen as distinct the study of institutions and that of the house and domesticity this collection provides new insights into the domestic experience of men women and children who lived in non family arrangements while also expanding and problematizing the notion of domestic interior Through specific case studies contributors reassess the validity of the categories domestic and institutional and of the oppositions private public communal individual religious profane applied to institutional spaces and objects They consider how rituals interior decorations furnishings and images were transferred from the domestic to the institutional interior and vice versa but also the creative ways in which the residents participated in the formation of their living settings A variety of secular and religious institutions are considered hospitals asylums and orphanages convents colleges public palaces of the ducal and papal court The interest and novelty of this collection resides in both its subject matter and its interdisciplinary and Europe wide dimension The theme is addressed from the perspective of art history architectural history and social gender and cultural history Chapters deal with Italy Britain the Netherlands Flanders and Portugal and with both Protestant and Catholic settings The wide range of evidence employed by contributors includes sources such as graffiti lottery tickets or garland pictures that have rarely if ever been considered by historians

Mad Tuscans and Their Families Elizabeth W. Mellyn, 2014-04-02 Based on three hundred civil and criminal cases over four centuries Elizabeth W Mellyn reconstructs the myriad ways families communities and civic and medical authorities met in the dynamic arena of Tuscan law courts to forge pragmatic solutions to the problems that madness brought to their households and streets In some of these cases solutions were protective and palliative in others they were predatory or abusive The goals of families were sometimes at odds with those of the courts but for the most part families and judges worked together to order households and communities in ways that served public and private interests For most of the period Mellyn examines Tuscan communities had no institutions devoted solely to the treatment and protection of the mentally disturbed responsibility for their long term care fell to the family By the end of the seventeenth century Tuscans like other Europeans had come to explain madness in medical terms and the mentally disordered were beginning to move from households to hospitals In Mad Tuscans and Their Families Mellyn argues against the commonly held belief that these changes chart the rise of mechanisms of social control by emerging absolutist states Rather the story of mental illness is one of false starts expedients compromise and consensus created by a wide range of historical actors

The Antonio II Badile Album of Drawings: The Origins of Collecting Drawings in Early Modern Northern Italy Evelyn Karet, 2017-07-05 Evelyn Karet s in depth study of the Antonio II Badile Album the earliest known example of an art collection pasted onto the pages of a book is both focused and broad in its appeal to those interested in the early modern era The provenance of the album is traced from its assemblage to the seventeenth century collection of Conte Lodovico Moscardo to its dismantling by the dealer Francis Matthiesen in the 1950s establishing that the volume conserved in the Frits Lugt Collection is not an original but a replica produced by Matthiesen Although Antonio II must be celebrated as the collector of the drawings new paleographic analysis has identified the actual compiler of the album after Antonio s death providing a terminus post quem in the late 1530s or early 1540s Karet enlarges

the focus from the album itself to the historic tradition of collecting drawings in northern Italy in the early modern era before Vasari for which the album provides a new point of reference Throughout the book Karet discusses the Badile family examines the individual drawings in the book investigates the contacts between artists and humanists their rich diverse collections and the humanist mind set that fostered the appreciation of drawings She explores notable early drawing collections in northern Italy and the role of northern Italy as a center of collection in the sixteenth and seventeenth centuries The book concludes with two appendices a reconstruction of the original album including a discussion of the reconstruction process suggestions about what the album originally looked like and a page by page guide to its contents and a detailed analysis of Francis Matthiesen s career This book opens up new areas of inquiry into an overlooked subject Plays, Poems, and Miscellaneous Writings associated with George Villiers, Second Duke of Buckingham Robert D. Hume, Harold Love, 2007-03-22 George Villiers Second Duke of Buckingham 1628 1687 was one of the most scandalous and controversial figures of the Restoration period He was the principal author of *The Rehearsal* 1671 an enormously successful burlesque play that ridiculed John Dryden and the rhymed heroic drama Historians remember Buckingham as an opponent who helped topple Clarendon from power in 1667 as a member of the Cabal government in the early 1670s and as an ally of the Earl of Shaftesbury in the political crisis of 1678 1683 The duke was prominent among the court wits Rochester Etherege Sedley Dorset Wycherley and their circle he was closely associated with such writers as Butler and Cowley he was a conspicuous champion of religious toleration and a friend of William Penn No edition of Buckingham has been published since 1775 partly because his work presents horrendous attribution problems He was probably adapter or co author of six plays two of them vastly successful for more than a century including one in French that appears here in English for the first time He is also associated with nine topical pieces variously political religious and satiric and some twenty poems of wildly varying type The Buckingham commonplace book has previously been published only in fragmentary form Almost all of these works present major difficulties in both attribution and annotation here seriously addressed for the first time This edition is a companion venture to Harold Love s important edition of Rochester OUP 1999 **The Fruit of Liberty** Nicholas Scott Baker, 2013-11-04 In the middle decades of the sixteenth century the republican city state of Florence birthplace of the Renaissance failed In its place the Medici family created a principality becoming first dukes of Florence and then grand dukes of Tuscany *The Fruit of Liberty* examines how this transition occurred from the perspective of the Florentine patricians who had dominated and controlled the republic The book analyzes the long slow social and cultural transformations that predated accompanied and facilitated the institutional shift from republic to principality from citizen to subject More than a chronological narrative this analysis covers a wide range of contributing factors to this transition from attitudes toward officeholding clothing the patronage of artists and architects to notions of self family and gender Using a wide variety of sources including private letters diaries and art works Nicholas Baker explores how the language images and values of the

republic were reconceptualized to aid the shift from citizen to subject He argues that the creation of Medici principality did not occur by a radical break with the past but with the adoption and adaptation of the political culture of Renaissance republicanism
