Economics is a study of a wide variety of questions.

Economy comes from the Greek term “oikonomos”, which is interpreted as “one who manages a household.”

Although a very peculiar interpretation, a household and an economy are very similar.

A household comes across many decisions, such as:

- Who cooks dinner?
- Who does the laundry?
- Who gets the extra dessert at dinner?
- Who gets to drive the car?

Just like an economy, a household has to allocate its scarce resources (time, dessert, car mileage).

Society must decide what and who does certain jobs.

Managing a society is difficult when important resources are scarce.

**Scarcity** is when society's limited resources prevent the production of the goods and services people wish to have.

In most modern societies, resources are allocated through the choices of millions of households and firms.
