and the AMA code of ethics has historically been recommended rather than required He examines what can be learned from the way society has coped with the conflicts of interest of other professionals lawyers government officials and businessmen all of which are held to higher standards of accountability than doctors And he recommends that efforts be made to prohibit and regulate certain kinds of activity such as kickbacks and self referrals to monitor and regulate conduct and to provide penalties for improper conduct Our failure to face physicians conflicts of interest has distorted the way medicine is practiced compromised the loyalty of doctors to patients and harmed society the integrity of the medical profession and patients For those concerned with the quality of health care or medical ethics *Medicine Money and Morals* is a provocative look into the current health care crisis and a powerful prescription for change
