- Remain calm.
- Call for help by dialing 911.
- Have someone stay with patient.
- Assign someone to guide emergency unit to patient.
- Have a phone as close to patient as possible.

Be prepared to follow the dispatcher's pre-arrival instructions and answer the following questions:

- Location of emergency.
- Problem.
- Number of patients.
- Phone number in case you are disconnected.
- If there is a defibrillator in the building, let 911 know.
- Is the patient conscious?
- Is the patient breathing? If not, the 911 operators will give you CPR instructions.
- Do not move patient unless patient is in imminent danger.
- Do not put yourself in danger.
