

National and international dimensions of research: Topics of local and global interest in scientific production

Abstract

This study aims at identifying and comparing the national scope of research at the country level of two groups of countries: LAC and World. We want to explore whether similar or different patterns arise between the two groups at the global and disciplinary level in their proportion of research related to local perspectives or topics. Findings show that LAC countries present a greater proportion of local production than the rest of the countries. The trend to publish national-oriented research is related to disciplinary fields and it is not only coarsened into national but in extra regional journals. Even though English is the dominant language of publication, the lingua franca is more likely to appear in the national scope of research, especially for LAC countries but also in the rest of non-Anglophone countries. Some implications in research evaluation for further research are described.

Introduction

There exist disparities globally when it comes to knowledge production and research capacities of countries, - limited access to research funding and opportunities in some countries (Demeter 2020). The modes of the knowledge production and circulation are affected by numerous factors, among them the geographic realm of research and disquisitions among the local, regional, national, and international scales, i.e., the simultaneous dimensions of activity (Marginson 2022). While national research agendas focus on both, development of strategic global topics to solve complex problems and topics oriented to the resolution of local issues, global geopolitics can also influence the development of scientific knowledge in local, national and regional contexts (Bennet 2014). Then the geographic scope of research may be seen as a valuable aspect of scientific development that helps orient agendas for science, technology, and innovation, while demonstrating the interest in certain “national” topics far beyond the domestic borders.

Traditionally, national scientific production is delimited as the contribution made by each country to the stock of worldwide scientific knowledge, using as a selection criterion the geographical origin of institutional affiliation of the publications’ authors. This conceptualization and its operationalization are usually used to benchmark the performance of national research systems. However, most studies are led by researchers based in the global north, even when they focus on a country or region in the global south (Amarante et al 2021), while there is a tension in the global south for dependencies of mainstream science to develop national research agendas of countries (Vessuri et al 2014). In this context, the extent to which national-oriented research about natural resources, economic, health or social issues inherent to their own territories is carried out by different countries has been less explored.

Some studies have analyzed the geographical realm of research considering coauthorship and topics of local interest among Colombian research groups revealing that this research contributes to the local stock of information necessary to increase local understanding and to produce new knowledge valuable to solve local intellectual, technical and/or social issues
