The practical part of the book contains an overview of 150 dilemmas that can be useful in legal ethics or other legal courses The dilemmas are divided into chapters covering the following branches of law criminal law civil and commercial law family and custody law labour and social security law and constitutional law Every dilemma presents a description of the facts a reconstruction of dilemma its standard solution and some critical remarks from a meta ethical
