- **Wrongful Diagnosis**

Wrongful diagnosis is one of the most common types of medical negligence or medical error. In most cases, the health condition of patients worsens due to a misdiagnosis. When a medical professional overlooks a symptom or misreads a test, they fail to identify the exact issue. As a result, it may lead to a wrongful diagnosis and consequently improper treatment, and naturally this impacts the health of the patient.

- **Anaesthesia Disasters**

During several surgical procedures, anaesthesia is used to prevent the person from experiencing pain. However, medical professionals must be well aware of the precise dose of anaesthesia to be administered to patients. Overdose can be fatal and can lead to stroke, traumatic brain injury, or death. Therefore, mistakes in administration and dosage of anaesthesia are considered a case of medical negligence.

- **Wrong Treatment**

Another common example of medical malpractice or negligence is the wrong treatment. In some cases, medical practitioners fail to identify the illness and subsequently prescribe incorrect medications. Sometimes, there are chances a healthcare professional may prescribe a medication that is contraindicated for a patient and as a result, worsens the condition of the patient.
