Hereby decree the following:

First: approval of the Practice of Engineering Professions Regulating Law in the attached text.

Second: Engineers not professionally registered at the time of these regulations going into effect must rectify their status in accordance with the provisions of these regulations within 6 months from the date of validation. SCE may extend this period.

Third: The Deputy Prime Minister, ministers and heads of concerned departments are required to implement this decree as appropriate.
