Regional State Aid and Competition Policy Fiona Wishlade, 2003-01-01 The increasing importance attached to the economic and social cohesion of the European Union since the 1980s and the role of competition policy in achieving this objective has special significance for the control of regional aids given the general ban on State aid Regional aids are considered to have the potential to contribute to economic and social cohesion and to undermine its attainment The notion of competition policy as an instrument of economic and social cohesion has become a standard part of Commission rhetoric in defence of its actions This book is concerned with the influence of EU competition policy on the regional policies of the Member States It focuses on how the European Commission has interpreted the derogations from the State aid ban to enable the conduct of regional aid policies.
