Regulation in the Reagan-Bush Era Barry D. Friedman describes how the executive agencies and Congress responded warily and with skepticism yet allowed the changes to remain. The judiciary was also willing to retreat from time honored precedents that had preserved agency prerogative and now accorded due respect to the revolutionary Reagan reform initiatives. Institutions that competed for leverage in the system continued to exercise restraint in their mutual relations because they recognized that all benefitted from the others' viability. This book shows that conventional political science theories and models are now obsolete because of the eruption of presidential control into bureaucratic affairs. New review procedures have restructured relations between the president and the agencies and among the government's three branches because of Reagan's radical initiative.
