Finally, the paper focuses on the relationship between the executive and the interests of the private sector and its possible mediation through the political parties, and as was done too hastily in October 2012, civil society forums such as the CES. The first part outlines the major tax reforms that took place in the Dominican Republic between its democratic opening in 1978 and the 2012 efforts, along with the political and economic conditions in each case, with a special focus on the 1992 reform. Next, the document describes the rigidities that accumulated during that period, which were the legacy of crisis, international commitments, and the goals of the ambitious tax revenue goals of the National Development Strategy. The second and longest section describes the regional debate on tax policy and redistribution, while showing how the Dominican Republic is situated in this scenario, with statistics on the fiscal performance of the Dominican Republic and other Caribbean and Central American countries.
