Economy comes from the Greek term “oikonomos”, which is interpreted as “one who manages a household.”

- Who gets to drive the car?

Just like an economy, a household has to allocate its scarce resources (time, dessert, car mileage).

Scarcity is when society's limited resources prevent the production of the goods and services people wish to have.

In most modern societies, resources are allocated through the choices of millions of households and firms.
