Developing Principles of Forensic Mental Health Assessment

The past 15 years have witnessed a tremendous change in forensic mental health assessment (FMHA). For present purposes, this kind of assessment will be defined as evaluation that is performed by mental health professionals as part of the legal decision-making process, for the purpose of assisting the decision-maker or helping one of the litigants in using relevant clinical and scientific data. Such legal questions in the criminal area include sanity at the time of the offense, sentencing, and competencies to confess, plead guilty, refuse an insanity defense, waive the right to counsel, testify, stand trial, be sentenced, and be executed, and juvenile transfer. Civil legal questions include civil commitment, guardianship, competencies to consent to treatment and research, testamentary capacity, fitness to work, personal injury under both workers' compensation and tort laws, child abuse and neglect, and child custody.

The professions most commonly involved in FMHA are psychiatry, psychology, and social work. Some of the procedures employed by each of these disciplines are most characteristic of the particular profession involved; when psychiatrists (e.g., Appelbaum & Gutheil, 1991) write about the process of forensic evaluation, they differ in some respects from psychologists (Grisso, 1986a, 1998a; Melton, Petrila, Poythress, & Slobogin, 1997; Shapiro, 1991).

The growth and development of FMHA during the last 20 years within psychology has been part of the broader evolution of the specialty area of law and psychology. This area has been represented primarily by the American Psychology–Law Society/Division 41 of the American Psychological Association. It includes both research and applied compo-
