3. Madison was ordered not to deliver the commission to Marbury
4. Court rule in favor of Marbury
5. *IMPORTANT BECAUSE*: 1<sup>st</sup> time a congressional act was found unconstitutional. The case established **JUDICIAL REVIEW**.
