arguments over approaches to environmental issues can be viewed as contestation over the meaning of security in particular political contexts Central here is the composition and assumptions of the dominant security discourse to emerge regarding those issues a framework of meaning for the most important forms of action on behalf of a particular group defining the terms for meaningful contestation and negotiation about security itself within that group As such the book attempts to illustrate the dynamics of competition over the meaning of security with reference to environmental issues particularly focusing on instances of political change in the dominant security discourse through which that issue is approached In the process the author points to the central role of these dominant security discourses in underpinning the most practically significant actions regarding environmental issues such as deforestation and global climate change The book employs methodological tools that enable a focus on how particular frameworks of meaning are constituted and become dominant how they provide a lens through which various issues are approached and how discourses most consistent with redressing environmental change and the suffering of the most vulnerable might come to provide the framework through which security is viewed in particular contexts This book will be of much interest to students of Critical Security Studies geography sociology IR and Political Science in general
