Race

- is NOT based on biology; CREATED category with historical roots used to classify groups of people.
- historically was not determined by skin color but by class inequalities (e.l., the English defined the Irish as a "lower" race.)
- during colonial expansion by European nations, race was defined in terms of skin color where non-white people were considered "lower" races.
