

8. The Police and Criminal Evidence Act

In the mid 1980s in light of

1. various decisions by the (national) Court of Appeal to quash previous convictions based on confessions that were 'unreliable' (e.g. because of police behaviour)
2. media and public concern about police interviewing

the Government in England and Wales brought in the *Police and Criminal Evidence Act* which mandated that from **1986** all interviews with suspects be recorded (e.g. on audio-tape) and that to be admissible ***confessions had to be voluntary*** and not the result of coercion/oppression.
