#### Background

Traditional means of protection of individual freedom in the UK: we relied on the judges to protect our civil liberties when developing the common law

Civil liberties rather than human rights

"We are free to do anything that is not against the law"

Reliance on:

- the common law see e.g. Entick v Carrington 1765

 the democratically elected Parliament – e.g. Factory Act 1833; Representation of the People Act 1918; Race Relations Act 1976; Sex Discrimination Act 1975

#### THE EUROPEAN CONVENTION ON HUMAN RIGHTS ("ECHR")

#### Early history and ideology:

European Convention for the Protection of Human Rights and Fundamental Freedoms (4 November 1950) – entered into force 3 September 1953. It was based on the United Nations Universal Declaration of Human Rights 1948.

It was drafted as a statement of values in opposition to those of the dictatorships which had recently been defeated in the Second World War and which had led to the horrors of the Holocaust.
