on the claim of a party who has satisfied those prerequisites has been described as a "carefully limited exception" to Title VII's procedural requirements *Price v. Choctaw Glove and Safety Co.* 459 F.3d 595 (5th Cir. 2006). Provided that an act contributing to the claim occurs within the filing period, the court may consider the entire period of the hostile environment for purposes of determining liability. *Jordan v. City of Cleveland* 464 F.3d 584 (6th Cir. 2006). The Supreme Court has held that a plaintiff's timely filing of an EEOC intake questionnaire, which was followed by an affidavit stating "Please force Federal Express to end their age discrimination," constituted a charge, cautioning, however, that its permissiveness. *Mudge v. Macomb County*, 458 Mich. 87 (1998), 1998 WL 103985.
