The decline in corporate revenues is a combination of decreasing effective tax rates an increasing fraction of business activity that is being carried out by pass through entities particularly partnerships and S corporations which are not subject to the corporate tax and a decline in corporate sector profitability A particular aspect of the corporate tax system that receives substantial attention is the 35% statutory corporate tax rate Although the U S has the world s highest statutory corporate tax rate the U S effective corporate tax rate is similar to the Organization for Economic Co operation and Development OECD average Further the U S collects less in corporate tax revenue relative to Gross Domestic Production GDP 1 9% in 2009 than the average of other OECD countries 2 8% in 2009 This report discusses a number of economic considerations that may be made while evaluating various corporate tax reform proposals.
