an enterprise to the private sector does not mean an end to all problems Also privatisation is not an overnight process or a magic touch it will be a lengthy process Furthermore a decision that something can be privatised does not mean that it should be privatised In that context privatisation is not good or bad it is an economic and social instrument If it is well designed it may bring substantial benefits to the economy and society In many countries many state owned enterprises particularly the ones which are financially weak have still not been privatised.
