**Rebuilding Cleveland** Diana Tittle, 1992 *Rebuilding Cleveland* is a critical study of the role that The Cleveland Foundation the country's oldest community trust has played in shaping public affairs in Cleveland Ohio over the past quarter century Drawing on an examination of the Foundation's private papers and more than a hundred interviews with Foundation personnel and grantees Diana Tittle demonstrates that The Cleveland Foundation with assets of more than 600 million has provided continuing catalytic leadership in its attempts to solve a wide range of Cleveland's urban problems The Foundation's influence is more than a matter of money Tittle shows The combined efforts of professional philanthropists and a board of trustees traditionally dominated by Cleveland's business elite but also including members appointed by various elected officials have produced innovative civic leadership that neither group was able to achieve on its own Through an examination of the Foundation's ongoing and sometimes painful organizational development Tittle explains how the Foundation came to be an important catalyst for progressive change in Cleveland *Rebuilding Cleveland* takes the reader back to 1914 when Cleveland banker Frederick C Goff invented the concept of a community foundation and pioneered a national movement of social scientists business leaders and government officials that made philanthropy a more effective force for private involvement in public affairs Tittle follows the Foundation through the 1960s when it began a major new initiative to establish itself as a civic agenda setter and problem solver to the present as a new generation of Foundation leaders continues to build upon this renewed sense of purpose

The ARA was created in 1961 and remained in operation until 1965. Its goal was to assist communities, especially economically distressed ones in rural or undeveloped areas of the country, in generating employment opportunities. Unstated in the creation of the ARA was its intention to serve as an economic development project, mostly for Appalachia and the American South, where nearly all of its money was spent. Wilson argues that the ARA was doomed to fail from the beginning because of the requirement that federal officials not interfere with state and local priorities. It simply was not possible to implement a federal initiative in the South without running afoul of local interests. And to further complicate matters, the issue of race loomed in the background when ARA policies aimed to improve employment opportunities for Black southerners; they were invariably sabotaged by racist politics. This ambivalent legacy of the ARA is alive today. Wilson suggests, as areas of the nation that have struggled economically since the agency's original creation, including inner cities, Native American reservations, Appalachia, and the rural South, continue to founder. Gregory S. Wilson is an associate professor of history at the University of Akron and coeditor of the *Northeast Ohio Journal of History*. **Eagle-Picher Industries** Douglas Knerr, 1992 This comprehensive history traces the evolution of Eagle Picher Industries, a manufacturing firm based

in Cincinnati Ohio for almost 150 years Focusing on events prior to the company's involvement in toxic tort litigation which forced it to file bankruptcy this work examines Eagle Picher's development as a diversified industrial manufacturer From a closely held regional producer of white lead and other paint pigments Eagle Picher became an important miner and processor of non ferrous metals by investing in zinc lead fields in Missouri Kansas and Oklahoma during the early twentieth century Once ore reserves in these areas were depleted the company turned to manufacturing industrial goods and pursued an aggressive and unique expansion and diversification program during the post World War II era During the 1950s 1960s and 1970s Eagle Picher acquired over twenty five firms all manufacturers of industrial goods and assembled a broadly based specialized productive capacity Eagle Picher's history illustrates a number of important trends and concepts First its experiences in the late nineteenth century provide a valuable look at how smaller firms adapted to the forces of consolidation in the economy Further Eagle Picher's experience as an industrial manufacturer demonstrates the ways in which mid sized firms grew by focusing on market niches overlooked by larger firms Finally Eagle Picher's approach to acquisition and diversification is unique in today's competitive marketplace Eagle Picher's commitment to limited diversification built around historical strengths its acquisition of successful firms and its efforts to establish strong lines of communication and effective controls between the central office and the divisions stand in stark contrast to the efforts of many acquisitive firms during recent mergers
