



# Regulation Theory, Space, and Uneven Development: Conversations and Challenges

What would a reactivated or reanimated regulation theory look like? What parts of the regulationist toolkit are worth holding on to? And, two decades on from the regulationist heyday, what would need to be added to the regulation approach for it to gain traction in a more pluralized and diversified economic geography? It is with these ambitious questions that Brandon Hillier, Rachel Phillips, and Jamie Peck open their edited volume, catalyzing a highly productive series of theoretical engagements with the regulation approach. The book unfolds through a sequence of rich conversations between regulation theory and contemporary debates and interventions in economic geography, political economy, and beyond. Each chapter features a standalone discussion, but the book reads as a dynamic whole, enticing the reader to contemplate what a renewed intensification of regulationist scholarship would bring to these disciplines. Ultimately, it succeeds in showcasing the enduring merits of regulationist scholarship and contemplating the emergence of a refurbished and forward-looking regulationist program.

A key recurring theme in the book is that a macroinstitutional orientation, coupled with a sensitivity to the variability of capitalism across geographies and over time, renders the regulation approach highly generative and relevant to the study of contemporary capitalism(s). In chapter 3, for instance, Bok makes the case that these features render the regulation approach well suited to methodologically disrupting the field of urban studies, particularly in the wake of its increasingly dominant poststructuralist tendency to shy away from *global* analyses. The latter has resulted in what she terms the *missing macro*—a chronic analytical neglect of cross-contextual patterns and systemic recurrences in the study of the urban, prioritizing instead a focus on locality, difference, and uniqueness. Similarly, Hillier's chapter highlights the potential of the regulation approach to respond to the budding *new state capitalism* literature and its bold proclamations about the state's renewed role as promoter, supervisor, and owner of capital. He persuasively argues that a regulationist perspective allows us to conceptualize the capitalist state as contingent and dynamically evolving, acknowledging that "there is no 'normal' role of the state in capitalist society" and therefore no ideal type that states converge to or diverge from (p. 119). There is, in other words, much that can be gained from a renewed engagement with the regulation approach.

At the same time, the book is not afraid to (re-)reckon with some of the enduring critiques of the approach. Over the years, regulationist contributions have been critiqued—more or less justifiably—for their purported functionalism, Eurocentrism, analytical
