compliance calculated as its amount multiplied for the probability to be caught must be superior to the benefits of non compliance in order to let the sanction be effective As the benefits of non compliance can vary among firms sanctions need to be very high in order to be effective In fact sanctions are ordinary correlated to environmental damage and not to the benefits of non compliance But very high sanctions can be difficult to enforce as they appear unfair and can lead to dramatic consequences on firms and workers up to shut downs of plants Ambient standards reduce these problems but oblige the regulator to know a huge amount of information regarding the specific contribution of each polluter to the polluted body Information is difficult to obtain because of asymmetric information and costly to produce because it requires large and skilled regulating and enforcing organizations Nevertheless complex regulation is the base of any environmental policy framework as it allows the policy maker to fully exercise its power of composition of various interests in a relatively transparent way Economic instruments were the second wave


