Since the 1980s, the institutionalisation of effective revenue raising by regressive taxes during periods of high growth has ensured resistance to welfare state backlash during budget deficits and consolidated the diversification of state funding capacity among industrial democracies. This book challenges the conventional wisdom that progressive taxation goes hand in hand with large public expenditures in mature welfare states and qualifies the partisan-centred explanation that dominates the welfare state literature.
