Regulation of Network Utilities Claude Henry, Michel Matheu, Alain Jeunemaître, 2001 Propelled by deep technical economic and cultural changes network utilities have in the last twenty years entered a new era Since competition has been widely introduced and promoted we have experienced a radical change in the structure of the industries and the role of the state authorities Their role in managing monopolies has evolved into regulating new forms of markets which has resulted in the creation of independent regulatory authorities.
