- The Complaint fails to state a claim against Defendant on which relief can be granted. Neither the original mortgage nor the note with proof of assignment are attached to the Complaint. Simply filing a copy of the original note and mortgage is not sufficient; Plaintiff must produce evidence that it is the original owner or assignee of the original note and mortgage. Plaintiff has not shown that it is the real party in interest.
- The prosecution of a foreclosure action must be made by the owner and holder of the mortgage and the note. Plaintiff is not entitled to maintain this action in which it seeks to foreclose on a mortgage which Plaintiff has not adequately pled that it owns.
- 4. Plaintiff's pleadings fail to contain sufficient facts to establish whom the actual Plaintiff is, its relationship to Defendant and to the claim for foreclosure of the subject mortgage. The record fails to sufficiently identify whom the correct plaintiff is and therefore fails to allege facts sufficient to determine the standing of Plaintiff.
