

Lamotrigine Update and Its Use in Mood Disorders

OBJECTIVE: To provide a qualitative, systematic update and review of the pharmacology, pharmacokinetics, efficacy in mood disorders, adverse effects, and costs of lamotrigine.

DATA SOURCES: Citations obtained from MEDLINE searches (1985–September 2001) using lamotrigine as a text word, articles identified in reference lists of pertinent articles, abstracts presented at conferences, and research data from GlaxoSmithKline.

DATA EXTRACTION: English-language articles were considered for possible inclusion. Each title and abstract was examined to determine whether the publication contained up-to-date information relevant to the objective. Twenty clinical trials that provided data on response rates in mood disorders were tabulated.

DATA SYNTHESIS: Lamotrigine's primary action is to modulate voltage-gated sodium channels. Evidence suggests that it decreases glutamate transmission, directly reduces calcium influx, mildly blocks transmitter reuptake, and alters intracellular mechanisms of resting transmitter release. The average half-life of lamotrigine is approximately 24 hours, but decreases to approximately 7.4 hours when used concurrently with phenytoin, and increases to approximately 59 hours with valproic acid. Seven of the 20 clinical trials were randomized, double-blind, and controlled. Existing data are inadequate to evaluate lamotrigine use in major depression. The pooled response rates for patients with depressed, manic, mixed, and rapid cycling bipolar disorder were similar, ranging from 52% to 63%. Adverse effects are infrequent when the drug is used alone, but become more frequent when lamotrigine is combined with other anticonvulsants. While most rashes are mild, approximately 1 in 500 patients develops exfoliative dermatitis. A slow upward dose titration is recommended to reduce the incidence of serious rash, but this may delay the attainment of adequate dosage for 6 weeks. Lamotrigine has positive effects on cognitive function, but occasionally produces insomnia. Lamotrigine costs 2–4 times more than lithium, carbamazepine, and generic valproic acid.

CONCLUSIONS: When efficacy, adverse effects, and cost are considered, lamotrigine should probably be reserved as a second-line agent for bipolar depression.

Although a number of medications have been successfully used for mood stabilization, the need for better outcomes was emphasized in a recent prospective study.¹ Eighty-two patients, diagnosed with bipolar disorder and maintained on lithium, carbamazepine, or valproic acid, were evaluated after an average follow-up of 4.2 years. During this period, 68% of the patients experienced 2 or more relapses. Kaplan-Meier survival analysis indicated that the probability for a recurrence of mania or depression within 1 year was 37%.

Since carbamazepine and valproate are antiepileptic drugs (AEDs), it is not surprising that newly developed seizure medications are studied for their effects on mood.

Lamotrigine is one of the newer AEDs for partial epilepsy. In 1993, a battery of psychological tests designed to measure drug effects on health-related quality of life found little difference between lamotrigine and placebo.² However, patient scores on the Affect Balance (or happiness) scale, which is designed to measure positive aspects of mental health, increased by 94% ($p = 0.003$). The next year, an abstract³ presented at the annual meeting of the American Psychiatric Association reported that lamotrigine produced sustained clinical improvement in 2 patients with refractory bipolar disorder. In the ensuing years, a number of reports have been published on lamotrigine treatment of mood disorders.

Lamotrigine was available in 12 other countries before it was approved by the Food and Drug Administration in December 1994. At this time, >1 million patients have

Genetics and Epigenetics of Psychiatric Diseases, 2nd Edition Cunyou Zhao, Weihua Yue, Zhexiong Wen, 2020-10-09 Psychiatric diseases have a highly complex etiology aggregating in families but not segregating in a traditional Mendelian manner Recent approaches to understanding the causes of psychiatric disease have focused on describing the genetic contribution to major psychiatric illnesses the use of large scale genome wide association studies GWAS and exome sequencing has enabled a systematic exploration of genetic risk factors and identified over 100 independent genomic loci significantly associated with psychiatric diseases however there remains uncertainty about the causal genes involved in disease pathogenesis and how their function is regulated Since many GWAS variants reside in non coding regions the disease associated common variants might be enriched in regulatory domains including enhancers and regions of active chromatin state These lead us to focus on the possible role of non sequence based genomic variation in health and disease Of particular interest are epigenetic modifications that regulate gene expression through modifications to DNA RNA histone proteins and chromatin The availability of high throughput profiling methods for quantifying epigenomic modifications in large numbers of samples has enabled us to perform epigenome wide association studies EWAS aimed at screening methylomic variations associated with environmental exposure and disease Thus systematic integration of genetic epigenetic and epidemiological approaches will contribute to improving our understanding of the molecular mechanisms underlying disease phenotypes
